

## Daily Legislative Update

Tuesday, April 9, 2019

As the temperature continues to rise outside, the same can be said for the inner workings of the 2019 legislative session! Yesterday we saw legislators engaged in (at times) heated debates on a number of bills both in committees and on each chamber's floor. Highlighting the day was an amended Capital Improvement Board bill (SB7) that, among other things, removed MLS requirements for a potential stadium project located in Broad Ripple. SB516 (Regulation of Hemp) was also amended during 2nd reading in the House to maintain the legality of hemp/CBD products currently on the shelves of many retail stores across the state.

Today, the House Ways & Means Committee will hold the final hearing for SB552 (Gaming bill) before deadlines. The committee will meet at 9AM and can be live streamed in its entirety by using the webcast links below.

With today being the Committee Report deadline for the House, they will have a handful of committees set to meet for the last time. Family/Human Affairs will start off at 8:30AM, followed by Financial Institutions and Utilities at 10:30AM. As we mentioned yesterday, ALL Senate bills in the House must be voted out of committee and have reports filed on their behalf by day's end.

Across the hall, the Senate's Tax/Fiscal and Homeland Security Committees will gather at 9 & 10AM respectively. Both houses will meet for session at 1:30PM.
